## PSC EXTENDS COMMENT PERIOD ON VOICE LINK

— Additional Comments Sought on Verizon Wireless Voice Link Service —

Albany, NY—07/09/13—The New York State Public Service Commission (Commission) today announced that it has extended the public comment period until September 13, 2013, to allow customers in western Fire Island, and other interested parties, time to fully evaluate Verizon New York Inc.'s (Verizon) Voice Link service during the summer months.

On May 16, 2013, the Commission issued an order allowing Verizon to use wireless Voice Link service as an alternative to basic landline service to customers on the western portion of Fire Island, on a temporary basis only, pending further review.
