New York State Siting Board to Meet

— Siting Board to Consider Appeals Related to Galloo Island Wind and Hecate Solar —

ALBANY — The New York State Board on Electric Generation Siting and the Environment (Siting Board) will meet on Monday, December 10, 2018 at 2 p.m. to consider an interlocutory appeal related to the Galloo Island Wind project that is proposed to be constructed and operated in Jefferson County, and at 3 p.m. to consider an interlocutory appeal related to the Hecate solar energy project proposed to be constructed and operated in Greene County.
