**State Board on Electric Generation Siting and the Environment to Meet
-Meeting to Discuss TransGas Energy Systems Petition for Rehearing-**

Albany, NY—7/3/08—The Board on Electric Generation Siting and the Environment (Siting Board) has scheduled a meeting for Monday, July 14, 2008, at 1:30 p.m. in the 19th floor Board Room of the New York State Department of Public Service at Three Empire State Plaza, Albany, New York.

The purpose of this meeting is to consider the Petition for Rehearing filed by TransGas Energy Systems LLC (TransGas) concerning the March 21, 2008 decision by the Siting Board dismissing TransGas' various proposals for a certificate of environmental compatibility and public need to construct and operate a generating facility in Brooklyn.

The meeting of the Siting Board is open to the public. However, since participants in the case pending before the Siting Board already have been provided opportunities to comment and respond to the application, participants will not address the Siting Board at the meeting.

The two additional members are Theodore Alatsas and Neil Sheehan.
