To All Active Parties:

The second full paragraph on page 18 of the August 14, 2008 Ruling states in part that: (1) all further comments must be served electronically on the judges and all other active parties on or before 4:45 p.m. on the specified due dates (in this instance September 29, 2008); and (2) hard copies must be mailed to the Secretary for filing, postmarked on or before the applicable due date. These requirements are modified as follows:

1. Public (including redacted) versions of all further comments must be filed electronically with the Commission Secretary - secretary@dps.state.ny.us - and served electronically on the judges and all active parties on or before 4:45 p.m. on September 29, 2008.
2. Complete or unredacted versions of all further comments that contain information claimed exempt must be served electronically, on the judges and all the active parties eligible to take possession of such information, on or before 4:45 p.m. on September 29, 2008.
3. Only one hard copy of the public versions of any further comments must be mailed to the Secretary in order to perfect your filings. Such copies may be mailed, postmarked not later than September 30, 2008.

On a related matter, all active parties should understand that all public (including redacted) versions of any further comments will be posted promptly on the Entergy case page on the DPS web site. These

documents are posted as part of this Department's effort to afford easy and convenient public access to much of the information in this case. With that objective in mind, the attachment below may be of interest to active parties electronically filing and serving redacted versions of their further comments in this case.
