Virtual Public Statement Hearings and Comments Sought Regarding Champlain Hudson Power Express Project

ALBANY — The New York State Public Service Commission (Commission) will hold virtual public statement hearings on Wednesday, October 20, 2021, to receive public comments concerning a petition filed by CHPE LLC and CHPE Properties, Inc. to amend a Certificate of Environmental Compatibility and Public Need authorizing the building, operation, and maintenance of the Champlain Hudson Power Express Project. The proposed project is a high-voltage, direct-current transmission line extending approximately 330 miles from the New York/Canada border to a converter station in Astoria, Queens.

The certificate was granted in this proceeding by an order of the Commission that was issued on April 18, 2013. The Commission has previously granted amendments to the certificate on March 20, 2020, August 13, 2020, September 21, 2020, January 26, 2021, and May 14, 2021. Those amendments authorized changes regarding project construction filings and filing requirements, approving route modifications, and authorizing modifications to increase project capacity from 1,000 megawatts (MWs) to 1,250 MWs and increase the footprint of the Astoria converter station.

In a petition filed June 4, 2021, the developers requested that the certificate be amended to allow the addition of a new interconnection point in the Capital Region to enable upstate renewable generation facilities to transmit electric power to New York City. The petition also seeks authorization to reconfigure the high-voltage alternating current interconnection between the project's converter station in Astoria, Borough of Queens, and at the Astoria Annex Substation owned and operated by the New York Power Authority.

The petition may be reviewed online at the Department of Public Service web page, www.dps.ny.gov, by searching under Case 10-T-0139. The Commission will consider the developers' requests and may adopt or reject them, in whole or in part.

Those wishing to comment on the Amendment No. 5 Petition will have the opportunity to make a statement on the record at the public statement hearings. Any person wishing to provide a public statement at a hearing must pre-register electronically or by telephone by 3:00 p.m. on Monday, October 18, 2021.

To register electronically: Participants who will login electronically to the hearing may register to do so by visiting www.webex.com by the date indicated above, clicking “Join” at the top right-hand corner of the screen, inputting the appropriate event number listed above, and filling in the requested information.

On the appropriate date and time of the hearing, participants should visit www.webex.com, click “Join” at the top right-hand corner of the screen, and input the appropriate event number for the hearing. Participants will be asked to “select audio system.” It is recommended that participants choose to have the system “call me” or “call using computer.” The “call me” option will require participants to enter their phone numbers.

To register by telephone: Any participant who is not able to login to a hearing electronically may participate by phone. Call-in participants wishing to make a statement at a hearing must register to do so by the date indicated above by calling 1-800-342-3330, following the prompts to the appropriate hearing and then providing the following information: first and last name, address, and phone number.

On the appropriate date and time of the hearing, call-in users should dial 518-549-0500 and enter the appropriate access code, listed above, to join the hearing.

All participants will be muted upon entry into the hearing. The ALJ will call each person who has requested to provide a statement to speak. The ALJ will continue the hearing until everyone wishing to speak has been heard or other reasonable arrangements have been made to include their comments in the record. Reasonable time limits may be set for each speaker as necessary to afford all attendees an opportunity to be heard. It is recommended that lengthy comments be submitted in

writing and summarized for oral presentation. A verbatim transcript of the hearing will be made for inclusion in the record of this case.

To listen to the hearing: Any person who would like to listen to the hearing and not make a statement may access the hearing without pre-registering. The hearing will be livestreamed on the internet and available for viewing on the Department of Public Service's YouTube channel on the date and times listed above. To access the YouTube channel, visit the Department's website, www.dps.ny.gov, and click on the YouTube icon at the bottom of the homepage.

In addition, any person without internet access may listen to the hearing by phone by calling the phone access number, 518-549-0500, and entering the applicable access code identified for the date and time of the hearing.
