PSC ANNOUNCES PUBLIC HEARINGS ON LONG ISLAND

— Public Invited to Comment on Proposed Rate Increase for New York Water —

Albany, NY—08/31/09—The New York State Public Service Commission (Commission) today announced it will hold public statement hearings concerning a proposal by New York Water Service Corporation to increase its annual water service revenues by approximately \$3.5 million. The company provides water service to about 44,000 customers in the Town of Hempstead, Long Island.

Each hearing will continue for at least one hour and thereafter as necessary to accommodate speakers, but not beyond 4:00 P.M. and 9:00 P.M., respectively.

It is not necessary to make an appointment to speak at one of the public statement hearings. Persons will be called to speak after completing a request card. The hearings will be transcribed verbatim by a court reporter. The transcript becomes part of the official case record. Toll-Free Opinion Line: Leave a taped message on the Commission's toll-free opinion line at 1-800-335-2120. The number is designed to take comments on pending cases from in-State callers, 24 hours a day. Callers should press "1" to leave oral comments and follow the instructions given.

For each of these alternatives, the comments should refer to Case 09-W-0237, New York Water Service Corporation - Water Rates. All public comments are due as soon as possible, but must be received by not later than October 9, 2009.

All timely public comments, regardless of the method by which they are transmitted, become part of the official case record, are posted on the DPS web site for public inspection, and will be summarized for the Commission for consideration during its deliberations.
